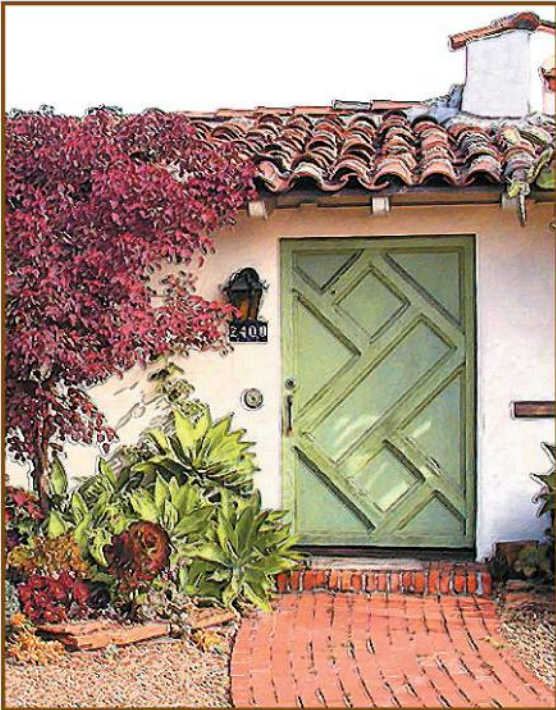

## THE QUITCLAIM DEED

This is a deed used to convey all interest, if any, held by the grantor in the property described in the quitclaim deed at the time the quitclaim deed is executed. The quitclaim deed, unlike the grant deed, does not use the word “grant(s)” as operative conveyance language. The quitclaim deed is often used to renounce any claim to the property. The grantor, by signing the quitclaim deed, is not warranting any ownership interest.

The quitclaim deed is very often used to clear a “cloud on the title” or to relinquish a purported interest held by the grantor, e.g., by virtue of the community property laws, etc. The quitclaim deed is a form of deed containing no warranties and conveying only the current right, title and interest of the grantor, if any, to real property. The attached explanation of the quitclaim deed form is provided for information only. It is not to be relied on in interpreting the full legal effects of the document.
